Mr. Chamley:

Please understand neither I or any of the lawyers that are working on behalf of the Estate of Michael Jackson represent Katherine Jackson or any other members of the Jackson family. We represent the Special Administrators of the Estate of Michael Jackson and in that sense represent the Estate. As I told Dr. Klein last week, Dr. Hoefflin DOES NOT speak for the Estate, is not authorized to speak for the Estate, nor do we condone his making public statements about Dr. Klein. We do not know the truth of whatever it is Dr. Hoefflin has publicly said about Dr. Klein but whatever those statements are they were not made with authorization by the Estate or the Special Administrators.

Katherine Jackson and the individual Jackson family members are represented by attorneys different than those representing the Estate or the Special Administrators. If the Jacksons have authorized or approved of Dr. Hoefflin making statements on their behalf you need to deal with their attorneys or the Jacksons directly. I hope this clears up any misunderstanding about the Estate or the Special Administrators position regarding Dr. Hoefflin's comments. If you have any questions feel free to contact me.
